**POST-TRIAL ORDER NO. 4**

**AND NOW** this 6th day of February, 2025, it is hereby **ORDERED** as follows:

1. Defendants' Motion to Clarify (ECF 327) is **GRANTED in part and DENIED in part without prejudice.**
2. The Post-Trial Order No. 1 (ECF 319) schedule is superseded by the schedule provided in Post-Trial Order No. 3 (ECF 326). Post-Trial Order No. 3 (ECF 326) governs unless otherwise superseded in part by this Post-Trial Order No. 4.
3. The Court hereby delays Defendants' further identification or revision of benefits consultants or experts. Defendants can revise or supplement their identification within **ten (10) days** after the date on which Plaintiffs identify their benefits consultants or experts.
4. Per Post-Trial Order No. 3, Plaintiffs' Motion for Recovery of Damages and/or Equitable Relief ("Plaintiffs' Motion) is due **March 7, 2025**. Defendants shall respond to Plaintiffs' Motion on the merits within **twenty-one (21) days** from the date Plaintiffs' Motion is filed.
5. The Court defers ruling on the outstanding remedies issues until after Defendants' Response to Plaintiffs' Motion, including expert or consultant reports or briefs.
6. The Court may decide to retain its own benefits expert or consultant pursuant to Federal Rule of Civil Procedure 706.

7. The Court believes it is reasonable and helpful for each party to identify experts before Plaintiffs' Motion and any expert or consultant reports are filed. Defendants may supplement their identification of expert within fourteen (14) days after Plaintiffs' Motion is filed.
8. Plaintiffs' Motion and Defendants' Response shall include briefs and attach a report by experts or consultants as provided in Federal Rule of Civil Procedure 26(8)(2)(b).
